The last few weeks have seen a resurgence in the right-wing's assault on the rights of women. These attacks have taken many forms, including an attempt to undermine the free contraceptive coverage that was a part of the health reform law. In the House Judiciary Committee, we have also seen a renewed attack on reproductive rights in the form of H.R. 3541. This bill would force doctors to guess the motive of any woman seeking an abortion and to then refuse her request if the doctor determines her reason for terminating the pregnancy is based on the race or sex of the fetus.

This is nothing more than a ploy to harass women who seek abortion services and the doctors who provide them. global economy also present some of the greatest vulnerabilities to our national security. Ships bound from all over the world arrive in our country in places like the Port of New York and New Jersey, most without having ever been adequately scanned for threats such as chemical or nuclear weapons. To address this threat, I authored legislation to improve port security that became law in 2007 as part of H.R. 1, the *Implementing Recommendations of the 9/11 Commission Act*.

Principal among these provisions was the requirement that, by July 12, 2012, all cargo containers be scanned by nonintrusive imaging equipment and radiation detectors before being loaded onto a vessel bound for the United States. This would provide invaluable protection against the threat of a terrorist attack to the nation's 360 commercial ports and the communities they support. Yet, despite this Congressional mandate, the Department of Homeland Security will not be able to meet the 100% scanning mandate by the July 12 deadline for compliance.

This is why I recently testified before a Homeland Security Committee hearing on the measures necessary to secure our ports from potential terrorist attacks. I told the Committee that further delays in 100% scanning would only further jeopardize the security of ports and the millions of Americans who live near them. Click here to watch my testimony.
