“Forging a Path Forward” Town Halls

This summer I hosted a series of town hall meetings with various elected officials across the district to talk about fighting Trump’s dangerous agenda.

Introduced 9 Bills

including:

Marijuana Opportunity Reinvestment and Expungement (MORE) Act

The MORE Act would federally decriminalize marijuana and aims to correct the historical and continued injustices of failed drug policies.

West Bank Violence Prevention Act

The WBVPA, which has over 100 cosponsors, seeks to prevent acts of violence in the West Bank and to punish those who commit such acts, regardless of nationality.



Holocaust Expropriated Art Recovery (HEAR) Act

The HEAR Act would aid in the recovery of Nazi-looted art and deliver justice for Holocaust survivors and their families, and passed the Senate unanimously this month.

Refuge from Cruel Trapping Act

The Refuge from Cruel Trapping Act would prohibit the use of cruel body-gripping animal traps on public, protected lands.

Administrative State, Regulatory Reform, and Antitrust Subcommittee

This year, I was named Ranking Member of the Administrative State, Regulatory Reform, and Antitrust subcommittee of the Judiciary Committee.

The Subcommittee's jurisdiction includes bankruptcy and commercial law, bankruptcy judgeships, administrative law, independent counsel, state taxation affecting interstate commerce, interstate compacts, and antitrust matters. We held nine hearings, ranging on topics from artificial intelligence to health care to bankruptcy law and higher education.

I also sit on the Judiciary Committee's Immigration Integrity, Security, and Enforcement subcommittee. This year, I rejoined the Transportation & Infrastructure Committee, and its Highways and Transit and Railroads, Pipelines, and Hazardous Materials subcommittees.
